Agreement made between "VEHICLE OWNER/OPERATOR", and Minam Shuttle Service (herein referred to as "SHUTTLE SERVICE"), whose principal place of business is located at Minam Highway 82, Wallowa, Oregon.

RECITALS

1. SHUTTLE SERVICE is engaged in the business of transporting the vehicle of river rafters to the point of destination.
2. VEHICLE OWNER/ OPERATOR desires to engage SHUTTLE SERVICE to transport VEHICLE OWNER/OPERATOR’S vehicle on the terms, covenants and conditions set forth herein.

For the reasons set forth above, and in consideration of the mutual promises and agreements set forth herein, SHUTTLE SERVICE and VEHICLE OWNER/OPERATOR agree as follows:

SECTION 1: ENGAGEMENT

VEHICLE OWNER/OPERATOR hereby employs, engages, and hires SHUTTLE SERVICE to transport the vehicle listed above:

VEHICLE OWNER/OPERATOR agrees to pay SHUTTLE SERVICE \$_____ for such transport, and to pay promptly /reimburse all expenses arising out of or attendant to such transport, including, without limitation, gasoline/diesel for the vehicle.

SECTION 2: VEHICLE OWNER/OPERATOR’S REPRESENTATIONS:

VEHICLE OWNER/OPERATOR makes the following representations:

1. The vehicle is safe to drive, is in the condition described above, and has no material damage or defects not described above.
2. The vehicle has a full tank of fuel (or cash for refueling will be left with the keys), and all other fluid levels are adequate.
3. All trailers are adequately secured, and all loose items are adequately fastened.
4. All keys needed to operate and refuel the vehicle (including keys to compartments and trunks to which VEHICLE OWNER/OPERATOR wants SHUTTLE SERVICE to have access) will be provided to SHUTTLE SERVICE.

SECTION 3: DISCLAIMER OF RESPONSIBILITY

Driving a vehicle has built-in risks. SHUTTLE SERVICE employees are instructed to drive carefully and to obey the law at all times. Still, because of the risks of driving, ALL SERVICES PROVIDED UNDER THIS AGREEMENT ARE AT THE VEHICLE OWNER’S SOLE RISK. VEHICLE OWNER/OPERATOR shall indemnify and hold harmless SHUTTLE SERVICE against all loss, cost or damage on account of any injury or damage to person or property arising out of the performance of this contract.

SECTION 4: INSURANCE RELEASE CLAUSE

The VEHICLE OWNER/OPERATOR hereby covenants and warrants that the vehicle has full collision insurance and liability insurance in the minimum amount of \$25,000.00. VEHICLE OWNER/OPERATOR thereby acknowledges that SHUTTLE SERVICE has no liability or collision insurance covering the VEHICLE OWNER/OPERATOR’S vehicle and agrees to indemnify and hold harmless SHUTTLE SERVICE against all loss, cost arising out of the performance of this contract and the operation of the VEHICLE OWNER/OPERATOR’S vehicle by SHUTTLE SERVICE.

SECTION 5: CONSTRUCTION

The Section headings used herein are for convenience only, are not a part of this AGREEMENT, and are not to be used in its construction. Singular terms used herein shall be read as if written in the plural when the context so requires or permits.
